

# BATTLE IN THE BAY 2025: FRIDAY 28<sup>TH</sup> – SUNDAY 30<sup>TH</sup> NOVEMBER

**OFFICIAL REGISTRATION FORM** 

Registration Deadline: Sunday 9th November 2025, 11:59pm

#### 1. Registration Fees

- \$40 per dancer for the first entry / \$10 per dancer for additional entries
- \$10 per dancer for school entries

Late entries will incur a \$40 fee per small crew, crew, megacrew, or school or \$10 per dancer for solos, duos, and trios – no exceptions. Late entries are subject to availability.

#### 2. Manager / Guardian

Page 3 of this form (or the online registration) must be completed by a Manager or Guardian aged 18+.

#### 3. Dancer Waiver

- All dancers must sign & return a Dancer's Waiver & Release Form (page 4).
- Participants under 18 require a parent/guardian signature.
- Waivers are due by Friday 21st November and can be emailed or uploaded via the website.

#### 4. Payment

- Full payment is due by Sunday 9th November, 11:59pm.
- Invoices will be issued for each independent entry or studio, so we encourage you to submit entries early to ensure you receive your invoice well before the payment deadline.

## 6. Form Submission

• Registration & Waiver Forms can be emailed or submitted via the website. Photos or photocopies are accepted.

#### 7. Cancellations / Refunds

• Entries that withdraw for any reason after submitting forms and payment will not receive a refund.

#### 8. Managers & Helpers

- Each age division gets one manager backstage, except entries aged 12 and under, who can have one manager and one helper.
- Please provide your manager's name and contact when registering.
- If your manager can't attend, a substitute is allowed but we need their name and contact information.
- Helpers do not need to be named in advance; they'll receive a dancer's pass at registration.
- Solo, duo, and trio dancers competing in a small crew, crew, or megacrew won't be allocated a manager/helper unless an exception is requested.

#### 9. Music Submission

- Music is due by Friday 21st November, 11:59pm.
- Submit via email or upload on the website.
